Buy or Pay for Me

User agrees to pay any difference if the initial deposit paid is not able to cover for all purchases or service , shipping and applicable charges

Shika36 will refund to purchaser if the total cost of purchase,shipping and other applicable charges is lower than the deposit made.The difference will be refunded back to purchaser

Incase of any custom clearance charges when shipment arrives in Ghana purchaser is responsible for all charges

User agrees that Shika365 review fees are not refundable

User agrees that shika365 is not responsible is if there is lost or damage when package is transit to Ghana. User is responsible for tracking his/her own shipment

User agrees to choose a reliable shipping company when making purchase

User agrees to shop on reputable websites.

User agrees to provide accurate information for purchases and shipment

User agrees that Items bought on behalf of a customer may not be in their original packaging from the vendor on arrival. Shika365 may repackage items to save shipping coast to Ghana.

Buy a Car for me

User agrees that once the car is purchased there is no refund
